### **Background**

UNECE's Eastern Europe and the South Caucasus (EESC) sub-region has considerable potential for sustainable development. At the same time, the sub-region region is facing many challenges, including the negative impact of climate change, the COVID-19 pandemic, and conflicts. This requires/calls upon countries to respond to changing environments, emerging constraints, and opportunities. Innovation – trying out new ways of creating value through new or improved products, services, processes, and business models – will need to take centre stage in this process and evidence-based public policy will need to play an effective role in enabling and promoting this dynamic.

The <u>Sub-regional Innovation Policy Outlook (IPO)</u> is a UNECE flagship initiative funded by the Government of Sweden. It supports countries in addressing development challenges by assisting them in strengthening innovation policy governance and coordination within their national innovation systems, with the aim of spurring innovative and sustainable development. Following the <u>launch of the first IPO</u> iteration for the EESC sub-region in 2020, the second IPO iteration – the Interim IPO (IIPO) – takes stock of recent developments and the progress made in the sub-region. The IIPO launch will also home in on specific priority topics that provide avenues for improving innovation policy in the countries: include strengthening science-business linkages and facilitating use of innovation-enhancing procurement to increase innovative activity in the private sector. Numerous leading local and international experts, international partners and other representatives from the national public and private sectors have shaped the publication, including at dedicated <u>IPO policy dialogue</u> sessions

### Launch of the IIPO

The High-level IIPO Launch will form part of the <a href="16th">16th</a> Session of the UNECE Committee on Innovation, Competitiveness and Public Private Partnerships (CICPPP), UNECE's intergovernmental body, which is a platform for dialogue on policies that facilitate economic growth, innovation, entrepreneurship, effective regulation, corporate governance, and public-private partnerships across UNECE member States. The launch event will convene international experts, partners, and other innovation stakeholders in the EESC sub-region to review the findings and chart the way forward towards impactful implementation of IIPO policy recommendations".
