### Feedback from e-consultation on the document



### Replies to consultation

- 38 responses received (37 countries, 1 international organization)
- All supported endorsement, subject to the comments made during the consultation
  - Some quotes: 'inspires NSOs to reflect on their role' (Austria); 'really needed as it is first of its kind' (Finland); 'provides a balanced view of risks and opportunities for NSOs; an essential guide in strategizing NSOs' position within the national data chain while preserving their core statistical mission and values (France); 'an important step towards enhancing data stewardship practices and ensuring the NSOs continue to play a vital role in the new data ecosystem' (Slovakia); 'a pioneering effort; the need for data stewardship is crucial both today and in the future (Türkiye).
- Work of the Task Force highly appreciated
- All respondents said that the report is useful and has improved their understanding of data stewardship
- Amendments resulting form the consultation are summarised in document ECE/CES/2023/2/Add.1



# Feedback from e-consultation on the Report



#### **Comments on future work**

- 27 countries would be interested in participating in further work on this topic (+7 possibly)
- Priorities:
  - Develop more specific guidance, recommendations and tools for implementing data stewardship;
  - A forum for exchange of experience;
  - Identify a core set of responsibilities of NSOs as data stewards in national data ecosystems;
  - A knowledge base of best practices and examples of successful data stewardship implementation, including more detailed practical examples.
- Additional future work proposals:
  - Barriers for NSOs to stepping into the data stewardship role
  - Ethical guidelines for providing data related services
  - Periodic reviews how NSOs are pursuing their data stewardship roles
  - Data stewardship and administrative records
- Coordinate with other similar initiatives (global Working Group, other Regional Commissions, etc.)
