### Summary

This document provides an overview of capacity-building and technical assistance activities undertaken as part of the Trade subprogramme programme of work. It also includes the overview of the fundraising activities carried out by the Economic Commission for Europe (ECE) Economic Cooperation and Trade Division in 2022-2023 and planned activities since the seventh session of the Steering Committee that are subject to extra-budgetary funding.

The report takes into account the recommendations from the evaluation of the ECE Subprogrammes 4 (Economic Cooperation and Integration) and Subprogramme 6 (Trade) by the United Nations Office of Internal Oversight conducted in 2022.

# Main activities in trade facilitation and digitalization

- 12<sup>th</sup>, 13<sup>th</sup> & 14<sup>th</sup> Odessa seminars (7.07.22, 22.12.22, 22-23.05.23, Baku) maintain the momentum of trade facilitation, e-business and data sharing in the region. Link to the implementation of the EU eFTI Regulation and the underlying UN/CEFACT semantic standards and MMT RDM.
- International high-level Conference on digitalization of data and document exchange in cross-border supply chains, using UN standards, Baku, 31.10.2022 (request to UNECE to develop a roadmap for this digitalization in the Joint SPECA Ministerial Statement from 17.04.2023)
- UNDA T14: Several pilot projects on the implementation of the package of standards for digitalization of multimodal data and document exchange, e.g., concept of data pipeline on exports of grain in the Black Sea; digitalization of the railway consignment note along the TRACECA route.



Draft Trade Facilitation Strategy of Uzbekistan








## Data pipeline concept (e.g., in BSGI)

# Sustainable Trade Principles

- Capacity-building on the nexus between Sustainable Trade, Water Management, Food Security, Trade Facilitation, and the Circular Economy, 21 November 2022, Astana, QazTrade.
