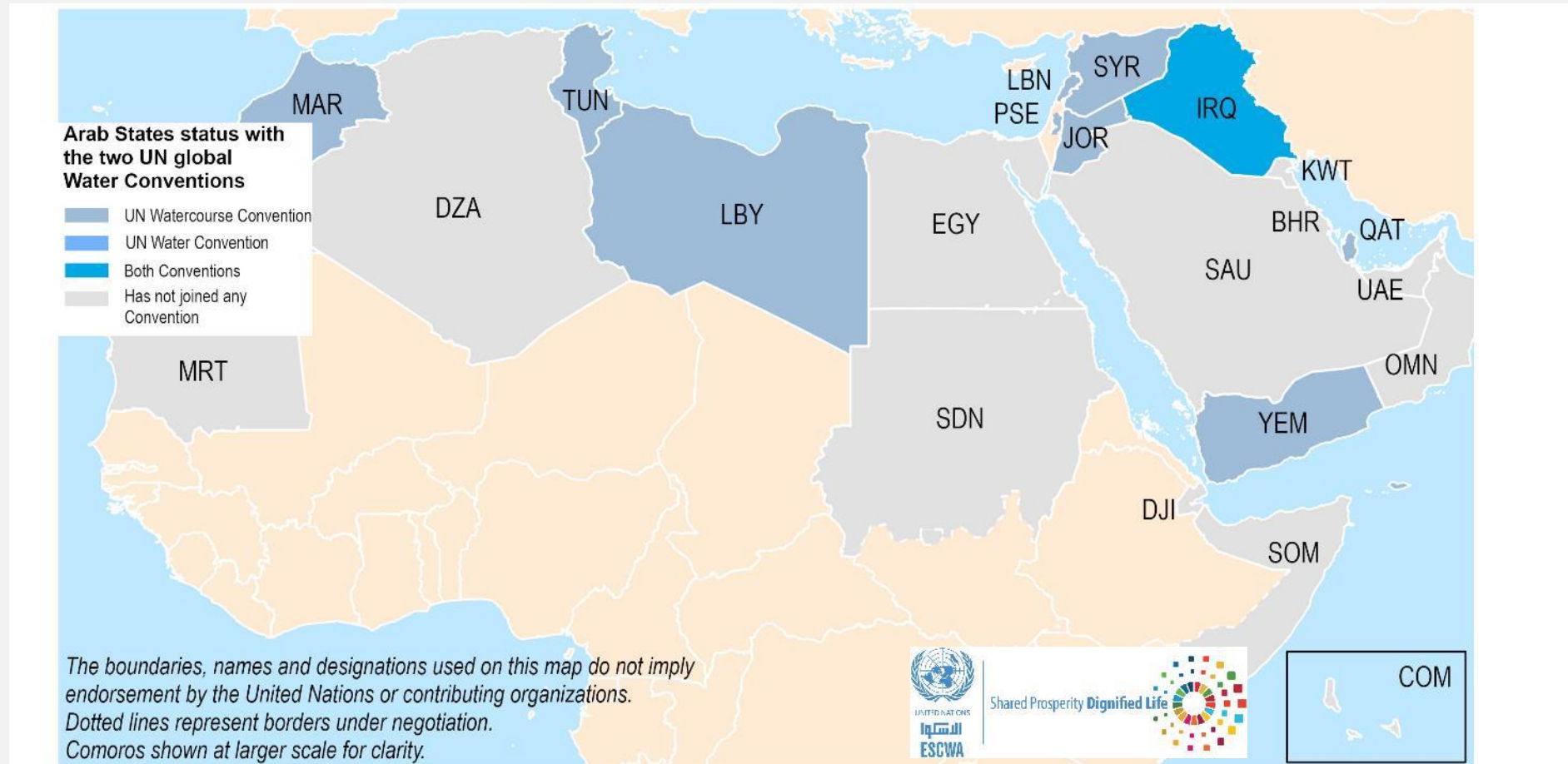


# Two Regional reports for SDG indicator 6.5.2 on Transboundary Cooperation in Arab States

- Recommendation to benefit from global cooperation.

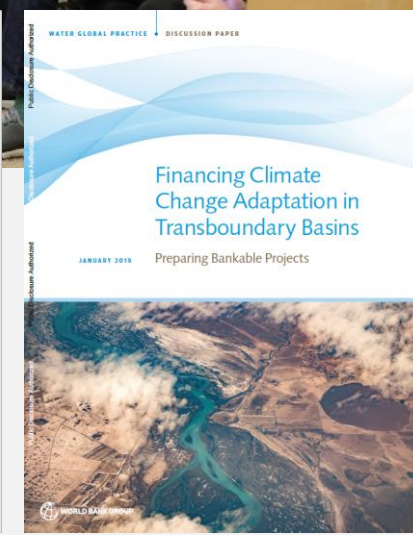
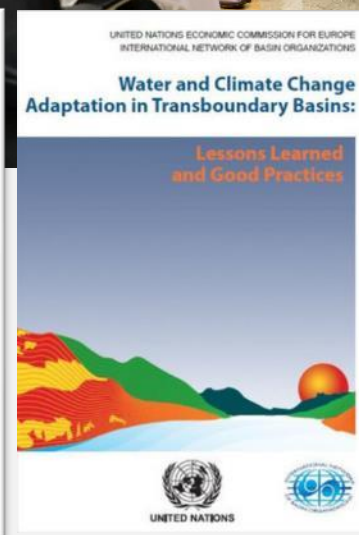
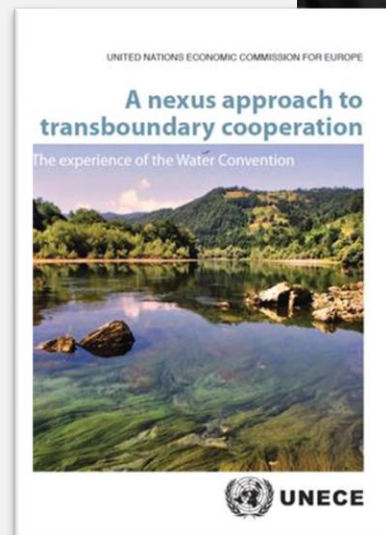
