Summary

This brief report aims to update the Plenary on the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT) Bureau activities since the election of new Bureau Vice Chairs in June 2020. It provides a concise overview of the developments of each Programme Development Area as well as three annexes presenting a list of all UN/CEFACT Bureau decisions since the last Plenary session, a list of all conferences attended which were reported in regular UN/CEFACT Bureau calls and a list of all projects which were active during this reporting period.

Document ECE/TRADE/C/CEFACT/2021/4 is submitted by the Bureau to the twenty-seventh UN/CEFACT Plenary for information.





A. UN/CEFACT Bureau reporting on the year 2020

- Since the elections of the new Bureau Vice Chairs in June 2020 until the end of the year, the UN/CEFACT Bureau has held eleven regular Bureau calls during which project development and procedural points were discussed. As per the *Consolidated UN/CEFACT Mandate and Terms of Reference* (ECE/TRADE/C/CEFACT/2017/15) article 49, a list of all Bureau decisions is provided in Annex I. There were 71 Bureau decisions during this period.
- 2. The structure of the Bureau and the responsibilities of the Vice Chairs (VC) was updated after the elections and the following distribution of Programme Development Area (PDA) responsibilities were established by Bureau decision 2006001. (Figure below)




Figure: Bureau structure since June 2020

- 3. The Domain Coordinators and Focal Points were nominated by the Bureau in July 2020 for a two-year term by Bureau decision 2007020. This decision was made in line with the procedures outlined in the *Terms of Reference for Domains and Domain Coordinators* (ECE/TRADE/C/CEFACT/2016/13) following a call for candidatures published on the website on 9 June 2020. The current Domain Coordinator and Focal Points are as follows:

- 4. The Bureau and secretariat strive to keep track of all meetings at which UN/CEFACT is officially represented. There is a conscious effort to ensure that the work is presented in a consistent manner in the interest of the organization. Thirty-nine such events were recorded on regular Bureau calls; the majority of these concerned harmonization and data models. The full list is available in Annex II.
- 5. A full list of all projects that were active between June and December 2020 and their status is available in Annex III. As per the UN/CEFACT *Open Development Process* (ECE/TRADE/C/CEFACT/2016/17) article 24, all new projects submitted during this period are highlighted in this table.
- 6. As of December 2020, there are 1547 experts registered within UN/CEFACT.

B. International Trade Procedures Programme Development Area

- 7. Since the last Bureau report, the International Trade Procedures (ITP) PDA completed Recommendation No. 38 on Trade Information Portals (ECE/TRADE/C/CEFACT/2021/6) and Recommendation No. 44 on Cross-Border Facilitation Measures for Disaster Relief (ECE/TRADE/C/CEFACT/2021/7). It also launched and completed Recommendation No. 47 on Pandemic Crisis Trade-Related Response (ECE/TRADE/C/CEFACT/2021/9). Two recommendation code lists were updated: Recommendation No. 20 on Codes for Units of Measure Used in International Trade and Recommendation No. 21 on Codes for Passengers, Types of Cargo, Packages and Packaging Material.
- 8. Potential future work includes
 - guidance on private sector involvement in trade facilitation measures and, more specifically, in National Trade Facilitation Bodies;

- a possible revision of Recommendation No. 18 on Facilitation Measures Related to International Trade Procedures:
- an assessment methodology for Single Window effectiveness; and
- guidance on the relation of a Single Window to specific technologies such as cybersecurity and machine learning.

C. International Supply Chain Programme Development Area

- 9. Since the last Bureau report, the International Supply Chain (ISC) PDA completed *Recommendation No. 45 on Minimum Standards for Ship Agents and Ship Brokers* (ECE/TRADE/C/CEFACT/2021/8) and launched and completed e-business standards in support of COVID-19 relief: the Export Packing List e-business standard and the Forwarding and Transport e-business standard (this includes standards for the booking, the shipping instruction, the waybill, and the status report/request).
- 10. Current active projects of the ISC PDA include the following:
 - Accounting and Audit Reference Data Model;
 - Automotive subset of the Supply Chain Reference Data Model;
 - Cross Industry Supply Chain Track and Trace;
 - Dangerous Goods e-business standard;
 - E-Negotiations e-business standard;
 - Healthcare Claims e-business standard;
 - IMO eFAL mapping;
 - Open Finance White Paper;
 - Reimbursement of Healthcare Claims:
 - Sustainable Tourism White Paper and Experience Program Technical Artefacts e-business standard; and
 - Transfer of title compliant to the UNCITRAL Model Law on Electronic Transferable Records (MLETR).
- 11. Potential future work may include sector-specific implementations of the Reference Data Models.

D. Regulatory/E-Government Programme Development Area

- 12. Since the last Bureau report, the Regulatory/E-Government (REG) PDA has completed the e-business standard for the *Rapid Alert System for Food and Feed*. The recommendation and e-business standards for the *Sustainable Textile and Leather Traceability and Transparency* project should be finalized and presented to the twenty-seventh Plenary as Recommendation No. 46 (ECE/TRADE/C/CEFACT/2021/10). This project also presents a Call to Action for Enhancing Transparency and Traceability of Sustainable Value Chains in Garment and Footwear for countries to adopt (ECE/TRADE/C/CEFACT/2020/6/Rev.1).
- 13. Current active projects of the REG PDA include the following:

- Cross-border inter-ledger exchange of preferential certificates of origin using blockchain technology;
- Digital identification for trade facilitation;
- Internet of things for trade facilitation;
- E-quality certificate;
- E-cert guide;
- UN/CEFACT chain project; and
- Waste management and waste analysis.
- 14. Potential future work may include work on artificial intelligence in trade facilitation, information security guidelines, electronic notarization, guidelines for standards-based information and communication technology (ICT) for government development strategies, digital corridors in support of landlocked countries, and blockchain-based authorized economic operator (AEO) mutual recognition.

E. Methodology and Technology Programme Development Area

- 15. The Methodology and Technology (M+T) PDA has finalized and published all semiannual releases for the UN/EDIFACT directories (D.20A and D.20B), the United Nations Code for Trade and Transport Locations (UN/LOCODE) directories (2020-1 and 2020-2), the Core Component Library (versions D.20A and D.20B) as well as the corresponding XML schemas (versions D.20A and D.20B). The specification domain has also completed a *Message Construction Guideline* and two standards for *Header-Envelope Document Exchange* (completed in cooperation with and harmonized with OASIS¹) and *Electronic Application Error and Acknowledgment*.
- 16. Current activities of the PDA include the work on guidelines for application programming interfaces (APIs) and how UN/CEFACT can deliver these types of message-exchange protocols to the user community in compliance with its thirty years of e-business standards.
- 17. Depending on the results of this guidance, a technical specification for API development from UN/CEFACT deliverables will likely be developed over the next period.
