3. Programme of Work

(a) Development of proposals for amending the AETR Agreement, including Article 22bis

At the last session, the Group of Experts was informed that no bilateral meetings between the Russian Federation and European Commission have been held. As a result, no compromise solution was found related to ECE/TRANS/SC.1/GE.21/2021/2. The Russian Federation reiterated that its position remains unchanged as per ECE/TRANS/SC.1/GE.21/2021/3. The Group will be invited to continue discussing this topic.

exchange of information). The Group will be invited to discuss the revised document (ECE/TRANS/SC.1/GE.21/2019/1/Rev.4) if submitted.

5. Extension of the Memorandum of Understanding between European Commission Services and United Nations Economic Commission for Europe

At the 117th session, SC.1 decided to authorize the Economic Commission for Europe (ECE) secretariat to sign the Administrative Agreement between the United Nations Economic Commission for Europe (UNECE) and the European Commission services for the continuation of the activities provided for in the 2009 Memorandum of Understanding between the European Commission services and the UNECE, for the period of 1 January 2023. until 31 December 2024. The secretariat and the European Commission held meetings to discuss possible solutions to the legal barriers preventing the secretariat from signing the Administrative Agreement. Additional meetings are proposed for further discussion. The group will consider the results of the meetings and get acquainted with the list of issues that were considered. The secretariat from signing the Administrative Agreement for detailed study and will provide an update on the matter and possibly also recommendations in Informal Document No. 1.
