## II. Annotations

### 1. Adoption of the agenda

In accordance with the Commission's rules of procedure, the first item to be considered is the adoption of the agenda.

### 2. Activities of United Nations Economic Commission for Europe bodies and other United Nations organizations of interest to the Working Party

#### Alignment of the work of the Working Party with the Inland Transport Committee strategy

The Working Party might wish to recall that, at its previous session (June 2023), it considered the proposals in annex III of document ECE/TRANS/WP.30/2023/1, containing suggestions for alignment of the WP.30 Terms of Reference (ToR) with the revised ToR of the Inland Transport Committee (ITC).

The Working Party (WP.30) mandated the TIR Secretariat to draft a response to the survey included in annex II of the letter from the Chair ITC and Director, Sustainable Transport Division, ECE to the Chair of the working party. The secretariat prepared document ECE/TRANS/WP.30/2023/6, which contains, proposals of alignment with the revised ToR of ITC, for consideration and, possibly, adoption by the Working Party.

Furthermore, the Working Party requested the secretariat to prepare a revision of document ECE/TRANS/WP.30/2023/1 including the discussions that took place and the suggestions proposed by the European Union and circulate it to all participants within one week. The Working Party also requested to include footnotes with justifications for a better understanding. The secretariat prepared document ECE/TRANS/WP.30/2023/7, for consideration and, possibly, adoption by the Working Party.

### 3. Customs Convention on the International Transport of Goods under Cover of TIR Carnets (TIR Convention, 1975)

#### (a) Status of the Convention

The Working Party will be informed about any changes in the status of the TIR Convention, 1975 and the number of contracting parties. In particular, the Working Party may wish to note that, in accordance with its Article 53, paragraph 2, the Convention entered into force for Iraq on 27 September 2023. With the accession of Iraq, the TIR Convention now has seventy-eight contracting parties. Since the activation of the system for Qatar, TIR operations can be established with sixty-five countries. Detailed information on this issue as well as on depositary notifications is available on the TIR website.<sup>1</sup>

**(b) Revision of the Convention****Amendment proposals to the Convention**

There are, at present, no amendment proposals to the Convention, submitted for consideration by the Working Party.

**(c) Application of the Convention****(i) Comments to the TIR Convention**

There are, at present, no comments to provisions of the Convention, submitted for consideration by the Working Party.

**(ii) eTIR***a. eTIR international system: interconnection projects*

The Working Party will be informed about the latest developments in the eTIR international system, based on version 4.3 of the eTIR specifications. The Working Party will also be informed about the status of the various interconnection projects.

*b. International TIR Data Bank*

The Working Party will be informed about developments related to the International TIR Data Bank (ITDB) and other information technology projects managed by the TIR secretariat, as far as they relate to matters of interest to the Working Party.

**(iii) New developments in the application of the Convention**

The Working Party is invited to raise new developments in the application of the TIR Convention, if any.

**(iv) TIR-related electronic data interchange systems**

The Working Party will be informed by the International Road Transport Union (IRU) about the latest statistical data on the performance of contracting parties in the control system for TIR Carnets — SafeTIR system.

**(v) Settlement of claims for payments**

The Working Party may wish to be informed by customs authorities and IRU about the current situation on the settlement of claims for payments made by customs authorities against national guaranteeing associations.

**(vi) Other matters**

The Working Party may wish to consider any other issues or difficulties in the application of the TIR Convention faced by customs authorities, national associations, the international insurers or IRU.

Under this agenda item, the Working Party may wish to recall that the secretariat, in close collaboration with the delegation of the European Union and IRU, prepared a draft survey, contained in document ECE/TRANS/WP.30/2023/3. The survey was sent on 14 March 2023 to customs TIR focal points with 31 May 2023 as deadline for reply. (see ECE/TRANS/WP.30/324, para. 20).

The Working Party considered the consolidated replies, as contained in Informal document WP.30 (2023) No. 12 and requested the secretariat to submit it as a formal document for its next session, including the remarks of the replies received. The secretariat prepared document ECE/TRANS/WP.30/2023/8, for consideration and, possibly, adoption by the Working Party.

**4. International Convention on the Harmonization of Frontier Controls of Goods, 1982 (Harmonization Convention)****(a) Status of the Convention**

The Working Party will be informed about the status of the Convention. Since the tenth session of the Committee, in 2014, only Turkmenistan has acceded to the Convention, in 2016, becoming the fifty-eighth contracting party to the Convention. More detailed information on the status of the Convention as well as on various depositary notifications is available on the ECE website.<sup>2</sup>

**(b) Issues in the application of the Convention**

Under this agenda item, the Working Party may wish to recall that, at its previous session (February 2023), it mandated the secretariat to circulate the 5-year survey on the application of Annex 8 of the Convention among the regular delegates from governments (and, in the absence thereof, TIR focal points) as addressees in April 2023 with 1 July 2023 as deadline for reply (see ECE/TRANS/WP.30/324, para. 26).

The Working Party may also wish to recall under this agenda item that, at its previous session (February 2023), it was informed that the ECE secretariat, in collaboration with the Organization for Security and Co-Operation in Europe (OSCE), was preparing “A practical guide to cross-border facilitation”, which would be available, in English, by mid-2023. The focus of this publication, which builds on the earlier joint OSCE-ECE Handbook of best practices at border crossings (published in 2012), is on transport facilitation in inland transport and it presents a good opportunity to promote some of the United Nations transport and border crossing facilitation tools, including TIR/eTIR, CMR/eCMR etc. The Working Party took note that the ITC would be requested to mandate the secretariat to prepare this publication as an official United Nations publication in the three ECE working languages, and to explore ways to do this by 2024, if possible. The secretariat informed the Working Party that a draft of the publication would be shared with delegations, with a request for comments or additional input (see ECE/TRANS/WP.30/324, para. 28).

The secretariat has prepared Informal documents WP.30 (2023) 4, 5, 6, 7 and 8, containing the first four chapters and an annex of this publication, for comments or additional input by the Working Party. As the Informal documents are in Word-format, delegates are invited to insert their comments/additions directly into the text and submit their amended versions to the secretariat ([wp.30@un.org](mailto:wp.30@un.org)).

**5. Convention on the Facilitation of Border Crossing Procedures for Passengers, Luggage and Load-Luggage carried in International Traffic by Rail****Status of the Convention**

The Working Party may wish to recall that, at its 156th session (February 2021), the delegation of the Russian Federation informed the meeting that, at the national level, all required procedures in preparation of signing the Convention had been completed and that a Government decree to that extent had been issued. Steps were being undertaken at the level

of the Ministry of Transport in order to facilitate signing the Convention in New York (ECE/TRANS/WP.30/312, para. 32). The Working Party further may wish to recall that, on 26 September 2019, Chad had become signatory to the Convention.<sup>3</sup>

The Working Party will be informed about the latest developments in this issue, if any.

## **6. Customs Conventions on the Temporary Importation of Private Road Vehicles (1954) and Commercial Road Vehicles (1956)**

### **(a) Status of the Conventions**

The Working Party will be informed that the status and the number of contracting parties to the Customs Conventions on the Temporary Importation of Private (1954) and Commercial (1956) Road Vehicles has not changed and that the Conventions have eighty and twenty-six contracting parties, respectively. More detailed information on this issue as well as on depositary notifications is available on the TIR website.<sup>4</sup>

### **(b) Issues in the application of the Conventions**

Under this agenda item, the Working Party will be briefed about any latest development in the context of a Memorandum of Understanding (MoU) between ECE and the Alliance Internationale de Tourisme / Federation Internationale de l'Automobile (AIT/FIA) on the revitalization and digitalization of relevant United Nations inland transport conventions and, in particular, the development of an eCPD (Carnet de Passage en Douane) system, if any.

Against this background, the Working Party may wish to recall that, at its previous session (June 2023), the Alliance Internationale de Tourisme / Federation Internationale de l'Automobile (AIT/FIA) made a brief presentation. Furthermore, it was informed that the team had started preparing the concepts of the future system, which would be submitted for consideration by the Working Party at one of its future sessions (see ECE/TRANS/WP.30/322, para. 30). The Working Party agreed to keep this item for further discussion at its next meeting where FIA proposed to present a more detailed presentation.

Delegations are also invited to raise, under this agenda item, any issue in the application of the Conventions, as far as they relate to matters of interest to the Working Party.

## **7. Introduction of new technologies in rail, road, road-based mobility, inland waterway, logistics and intermodal transport until 2030**

As part of the contribution of the Working Party to the ITC Strategy until 2030, delegations are invited, under this standing agenda item, to raise technological developments that could be introduced or applied within the context of the legal instruments under the auspices of the Working Party.

In particular, the secretariat invites delegations wishing to report on its efforts to contribute to the digitalization of the TIR Convention, to do so under this agenda item (see also ECE/TRANS/WP.30/312, para. 15).

## **8. Activities of other organizations and countries of interest to the Working Party**

The Working Party will take note of activities by various regional economic commissions or Customs Unions as well as by other organizations, both intergovernmental and non-governmental, and countries, as far as they relate to matters of interest to the Working Party.
