Developed and applied tools

A tool developed and first piloted in the Republic of Moldova.

The main beneficiaries of the guideline - coordinators of training sessions and trainers.

Pilot – 2 types of group:

- central public authorities representatives (45 persons)
- local public authorities representatives (113 persons)

The guidelines propose a set of methodological suggestions for setting up and conducting training sessions focused on the integration of ageing in public policies/development projects at the local level.

The intention of the guideline is to help trainers in their search for the efficient and comprehensive possible ways to work and interact with participants.

Conceptual background of workshop

- The aim of the workshop capacity building of public servants to assure the integration of the perspective of ageing into local public policies or development projects.
- The objectives of the workshop:
- strengthening skills to work with data to identify inequalities in relation to older persons
- 2. identifying the causes and consequences of inequalities and nonintervention
- 3. establishing the necessary measures to reduce inequalities in relation to older persons
- 4. determining ways to integrate the needs of older persons into national and local policies and local development projects

Conceptual background of workshop

- The strategy applied in the training combining practical and methodological aspects
- Methodological aspects the process and the stepts in mainstreaming ageing into policy presented
- Practical aspects analysing relevant data and policies
- The workshop was organised in several parts
- Working in small groups allow to the participants to analyze together, to share the knowledge and experience in analyzing and using data in the practical activity, to build bridges between professionals




Data-based policies

Public policies analysed (workshop with CPA representatives)

-Selection of actual policy documents that do not sufficiently mainstream ageing.

- -The selected public policies in the pilot:
- 1. Draft of Lifelong learning adult education national program
- 2. Draft of Public order and security program for the years 2022-2025
- 3. Draft of the National program for the prevention and control of priority non-communicable diseases in the Republic of Moldova for the years 2022-2030

The participants "discovered" gaps in the mainstreaming ageing in the policy documents reviewed and proposed solutions to ensure that the needs of older people are taken into account in the policymaking process.





Project proposals analysed (workshop with LPA

representatives)

- Analyzed project proposals developed by LPA within a national program dedicated to rural area development
- Gaps in mainstreaming ageing in project proposals, even the older population is one of the main beneficiaries of intervention
- Reccomendations how to improve the project proposal were developed






Workshop impact (survey results)

- "Until now, we have paid little attention to the principle of aging. Now we have convinced ourselves that it is important and needs to be integrated into all policies, strategies"
- "I liked the presentation of the concept and principle of aging, the analysis of inequalities in relation to the older population. I think there is still a need for training to adjust local policies to the dimension of active aging"
- 64% of the participants will consider the principle of ageing and the needs of older population in ther work
- 88% of the participants will recommend definitely and 12% will recommend the workshop to their colleagues
