

## **On multimodal transport**

#### **OVERVIEW "MULTIMODAL TRANSPORT LEGAL FRAMEWORK**"

Has been prepared in order to provide a basic understanding of the legal systems applicable to multimodal transport and to multimodal transport operators, briefly highlight the obligations and rules governing the activities of multimodal transport operators, and analyze existing legislative framework of the TRACECA countries.





#### **REVIEW OF THE MEASURES TAKEN TO PROMOTE MULTIMODAL TRANSPORT**

This Review examines in more detail the experience of countries (including TRACECA countries) in stimulating multimodal transport at the state level and the results from its application with a view to implementing the provisions of the Concept for the development of container transport until 2030

## **Proposals to Increase Competitiveness of Multimodal Transport**

## Exempting road carriers from taxes and fees for use of infrastructure

## Separate support measures for new investments in infrastructure and facilities

For example, exemption from customs duties and value added tax on the import of equipment, provision of state in-kind grants in the form of land plots, buildings facilities, machinery, etc.

> Implement measures concerning stimulation of exports by reimbursing part of the expenditure on transportation costs

It is proposed to adopt a comprehensive package of measures with a view to achieving a through tariff for the multimodal transportation of one 40-foot standard container (FEU) along the TRACECA corridor in the size of 3 000 US dollars

Cancelling the inspection of transit containers regardless of the country of departure and destination

On the basis of a risk assessment by the customs authorities

Adopt government policies, providing for separate measures to stimulate multimodal transportation

#### Adoption of consolidated measures to set a competitive through tariff

It would be appropriate to accept unified rates for rail transportation and to reduce the cost of maritime sections





#### SINGLE TRANSIT PERMIT

**Example-** transit transportation among the TRACECA countries



#### **Objective** of the Agreement on a Single Transit Permit

- Reducing the number of permits for transit transportations;
- Reducing the cost of transportation;
- Simplification of the transport process between the TRACECA countries;
- Increasing the return loading when transporting cargo by ferry vessels;
- Optimization of procedures for obtaining a transit permit;
- Applications of digitalization elements;
- Exclusion of the application of paper permits;
- Growing interest of countries in acceding to TRACECA

#### **MULTILATERAL PERMIT**

- Applied since 2016
- Used in 6 countries: Armenia, Georgia, Moldova, Romania, Turkey, Ukraine
- Gives the right to carry out bilateral and transit third countries







#### **DRAFT AGREEMENT ON VISA-FREE TRAVEL OF PROFESSIONAL DRIVERS**

Professional drivers have the right to enter and short-term stay (not exceeding 15 calendar days) in the territory or transit through the territory of the Parties of the Agreement.

- Conclusions and next steps The workshop welcomed and supported discussion on digitalization of international Customs transit systems, mutual recognition of AEO programmes and recommendation on minimum requirements for equipment of checkpoints; Specific Session 1, Session 2 and Session 3 conclusions are listed above in this Aid Memoire under each corresponding part; Suggested topics for next Customs issues workshop to be organized in November 2023 include:
  - Implementation of eTIR System along TRACECA corridor a) (existing practices for electronic interactions between Customs and railways and
  - b) use of electronic CIM/SMGS consignment note as Customs transit declaration potentials for further digitalization;

  - c) systematic information exchange mechanisms between Customs authorities: potential use of SEED system along TRACECA corridor

## **DEVELOPMENT OF CONTAINER TRANSPORT**

In 2030, the maximum estimated volume will be 760 thousand TEU containers or 9 thousand container trains

#### Concept for the development of container transport in the TRACECA corridor countries up to 2030

This document describes the trends in trade relations between the countries of the TRACECA corridor, the forecast of foreign trade of the countries of Europe and Asia for the last 20 years (75 countries were selected), "bottlenecks" and recommendations for their elimination.


To achieve these indicators, the activities of the Permanent Secretariat is focusing on removing technical barriers and determining competitive tariffs for container transport along the TRACECA routes.

#### **Cooperation with UIC**

Involvement in Study on Silk Road Middle and Southern Corridors/TRACECA routes (conducted by UIC and Roland Berger) - identification of bottlenecks and needs for action

Development of common approaches to use of electronic CIM/SMGS consignment note along the corridor





#### TARIFFS

It is proposed to take measures to reduce tariffs in neighboring countries and to carry out the process of their determination and make them more transparent. This requires cooperation from governments and modern structures at the state level.
