#### **Hazardous Waste**

- Risk for Human Health and the Environment
- 1980s:
  - Search for cheaper disposal solutions leads to increasing export from industrialized countries
  - Tragic Incidents and Public Attention
  - Example: "Toxic ships" sailing from port to port trying to offload poisonous cargo



#### **Basel Convention (https://www.basel.int)**

- Regulatory answer
- Negotiated under the UN Environment Programme in the late 1980s
- Entered into force in 1992
- Today 191 countries are parties to the Convention




#### **Basel Prior Informed Consent Procedure**

- Business-to-Administration/Authority (B2A) workflow
- Notification of intended waste movements to export, transit, import authorities
- Consents by all authorities required for waste movements
- Notification / consents often cover multiple movements over a defined period
  - such as 100s or 1000s of individual movements from Jan to Dec 2024
- The export country has the <u>duty to re-import</u> when there is a violation of terms

- Basel Convention Plastic Waste Amendments
- Effective since January 2021



#### **Basel Movement Document Provision (Art. 4)**

- Business-to-Administration(B2A) flow of information
- Paper form to accompany the movement from start to end (e.g. waste disposal)
- For each movement:
  - Announcement (in export country)
  - 2. Confirmation of receipt (in import country)
  - 3. Confirmation of the completion of recovery/disposal (in import country)



#### Digitalization benefits:

- a. Efficiency gains for businesses and authorities
- b. Better environmental control



#### **UN/CEFACT e-Basel Standard**

- Published in 2013
- Core Components and Business Information Entities
- Purpose: Interoperability
  - 1. Cross-Border
  - 2. Cross-Domain, such as with non-waste transport data exchanges
  - 3. Cross-System, for interconnecting a diverse range of IT solutions
- Covers Notification/Consent and Movement Document

Swiss-Austrian Data Interchange in operation since 2017



- Legislative process for a new EU Waste Shipment Regulation has started
- Requirement for all parties in EU to exchange data electronically
- Implementing Act will specify technical details
- EC operated TRACES.NT (hub) and connected IT solutions
- Integration with Electronic Freight Transport Information eFTI Regulation
- Integration with EU Customs Single Window
