## **II.** Annotations

#### 1. Opening of the meeting and adoption of the agenda

The Chair of the Standing Working Group on Ageing (SWGA) will open the sixteenth meeting. SWGA will then be invited to adopt its agenda as set out in the present document (ECE/WG.1/2023/1).

#### 3. Work of the Bureau

In the course of 2023, the Bureau worked by means of electronic consultations and online meetings in addition to its fifteenth meeting held in Istanbul, Türkiye, on 27 and 28 April 2023. The Chair will brief SWGA on the Bureau's work presented in document ECE/WG.1/2023/3.

## 4. International events and initiatives on ageing and follow-up to the 2030 Agenda for Sustainable Development

Members of SWGA will be briefed on relevant international meetings, events and initiatives on ageing in 2023. Briefings will cover the outcomes of the fourth review and appraisal of the Madrid International Plan of Action on Ageing (MIPAA) which concluded with the sixty-first session of the Commission for Social Development (E/RES/2023/15); the regional review and conference on the International Conference on Population and Development (ICPD30);<sup>1</sup> the Regional and High-level Political Forum for Sustainable Development, outcomes of the thirteenth session of the Open-ended Working Group on Ageing, activities by the Independent Expert on the enjoyment of all human rights by older persons, updates on relevant activities by the European Commission and activities under the United Nations Decade of Healthy Ageing.

Participants will be invited to inform SWGA about any major initiatives or events related to ageing.

#### 5. Implementing the goals of the 2022 Rome Ministerial Declaration

SWGA members will be invited to share new policy developments responding to the goals of the 2022 Rome Ministerial Declaration. The presentations will be followed by discussion.

#### 6. Programme of Work of the Standing Working Group on Ageing 2023– 2027

At its fifteenth meeting, SWGA delegated the task of developing the new programme of work 2023–2027 to the Bureau and decided to temporarily extend its membership to volunteers for this task. Following this invitation, Belgium, Canada, Italy and Norway contributed to the development of the proposed programme of work.

The Bureau will present the draft programme of work for the years 2023–2027 as contained in document ECE/WG.1/2023/INF.1. Members of SWGA will be invited to discuss the proposed programme of work and to approve it.

#### (b) International cooperation, exchange of experience and policy discussion

#### (i) Policy Briefs

The secretariat will present Policy Brief No. 28 "Older persons in vulnerable situations". SWGA members will be invited to propose priority themes for future policy briefs and decide on the topic for Policy Brief No. 29.

#### (ii) In-depth policy discussion

The secretariat will brief SWGA on the in-depth policy discussion in 2023 on the topic "Combating inequalities in older age". Members of the group are invited to discuss and decide on the topic for the in-depth policy discussion in 2024.

#### (iii) Online policy discussions in between annual meetings

The secretariat will brief SWGA on the planned online policy discussions in between annual meetings proposed in the new programme of work. Members of the group are invited to decide on the topics of the online policy discussions in between annual meetings in 2024.

#### *(iv) Peer learning*

Under this item, opportunities for peer learning will be discussed.

#### (c) Guidelines and policy recommendations, advisory services, and capacity-building

#### (i) Road maps for mainstreaming ageing

The secretariat will inform members about a new road map project in Uzbekistan initiated in 2023. Members of SWGA will be invited to express interest if they wish to develop a road map for mainstreaming ageing in 2024.

#### (ii) Capacity development on mainstreaming ageing

The secretariat will brief SWGA on new capacity development tools for mainstreaming ageing developed in 2023. Members of the group will be invited to update the group on trainings and workshops on ageing organized in 2023 and share plans for capacity development activities in 2024.

#### (d) Monitoring the implementation of the Madrid International Plan of Action on Ageing and its Regional Implementation Strategy and strengthening the evidence base for policymaking

#### (i) Ageing-related and age-disaggregated data

SWGA will be updated on international efforts on ageing-related and age-disaggregated data for monitoring, including activities by the Titchfield City Group, World Health Organization (WHO) and Eurostat.

#### (ii) Generations and Gender Programme

SWGA will be updated on activities under the Generations and Gender Programme (GGP) in 2023. Members of the group who have used GGP to inform policymaking or are planning to fund a survey are invited to share their experience.

#### (iii) Ageing Policies Database

The secretariat will report on progress in developing the UNECE Ageing Policies Database and outline plans for 2024.

SWGA will discuss the possibility of developing a quantitative monitoring framework for the fifth review and appraisal cycle of MIPAA/RIS in discussion groups.

## 8. Evaluation of the Ageing – Phase III project

The secretariat will brief SWGA on the outcomes of the evaluation of the project entitled "Improve capacities of UNECE member States in developing evidence-based policy measures to meet their commitments under MIPAA/RIS and 2017 Lisbon Ministerial Declaration: Ageing (Phase III)" as contained in document (ECE/WG.1/2023/INF.5). The secretariat will also present suggested responses to the recommendations of the evaluation.

Members of SWGA will be invited to discuss the outcomes and recommendations of the evaluation.

#### 9. Updating the Regional Implementation Strategy for the Madrid International Plan of Action on Ageing

At its fifteenth meeting SWGA decided to set up a task force for the follow-up on paragraph 47 of the Rome Ministerial Declaration. The Bureau, at its fifteenth meeting, nominated the Vice-Chair of SWGA (Germany) to chair the task force.

The Chair of the task force will inform SWGA on activities and present proposed modalities for updating the Regional Implementation Strategy. Members of SWGA will be invited to discuss and adopt the proposed terms of reference for the task force (ECE/WG.1/2023/INF.2) and the proposed modalities for the participatory approach (ECE/WG.1/2023/INF.3).

# 10. Programme of work for 2024 and outline of key components of the programme of work for 2025

In line with the "Sequential review of the proposed programmes of work of ECE subprogrammes", approved by the Executive Committee at its 115th meeting (Geneva, 5 March 2021), SWGA will be invited to adopt the draft programme of work of the population component of the housing, land management and population subprogramme for 2024 (ECE/WG.1/2023/5) and recommend that it be approved by the Executive Committee. The programme of work is based on the Economic Commission for Europe proposed programme budget for 2024 (A/78/6 (Sect. 20)) and follows the annual budget format approved by the United Nations General Assembly in resolution 77/267 of 30 December 2022.

Based on the sequential review procedure, SWGA will also be invited to consider the "Outline of the key components of the programme of work of the population component of the housing, land management and population subprogramme for 2025" (ECE/WG.1/2023/INF.4) and to provide recommendations on those components, as necessary. Those recommendations agreed by the Executive Committee and included in its decisions will be reflected in the proposed programme plan of the population component of the housing, land management and population subprogramme for 2025.

#### 13. In-depth policy discussion

This year's in-depth policy discussion will focus on the topic "Combating inequalities in older age". The event will present pertinent trends in socioeconomic and gender inequalities among younger and older generations in the UNECE region. It will explore the potential impact of other societal shifts, such as evolving labour markets and technological advancements, on inequalities among older persons, both now and in the future. The central aim of the event is to discuss the policy implications of these trends as well as to highlight concrete policy options for preventing and mitigating inequalities in older age.

## 14. Conclusions and closing of the meeting

The secretariat will summarise the key messages of the in-depth policy discussion.
