

#### 2011 First session

#### Mandate:

Set up "for the purpose of strengthening the protection of the human rights of older persons by considering the existing international framework of the human rights of older persons and identifying possible gaps

and how best to address them, including by considering, as appropriate, the feasibility of further instruments and measures,

and requests the Secretary-General to provide all necessary support within existing resources for the duration of its mandate".

# Outcomes OEWG-A 13

- > Draft decision of the core group about intersessional consultations
- The OEWG-A 13 decided by consensus to appoint two co-facilitators to conduct informal meetings between the 13<sup>th</sup> and the 14<sup>th</sup> session
- Ambassadors of Brasil and Portugal to the United Nations were appointed (Developed / developing countries)
- Aim of the co-facilitators' work: identify gaps in the protection of the rights of older persons and make recommendations on how to close them
- Questionnaire sent to Governments, civil society organisations and Human Rights Institutions



# Outcomes OEWG-A 13

- Crucial to respond to the questionnaire many answers needed for process to be reliable
- Come up with intergovernmental negotiated recommendations
- ➤ Themes for substantial input will be covered by the end of the 14<sup>th</sup> session
- Focus areas 2024: Participation in public life and decision-making / Accessibility, habitat, infrastructure and transport
- Ensure that the recommendations presented to the 14th session of the OEWGA set out clear options for a way forward
- Civil society and HRIs: Move to establish a mechanism to commence the drafting of a new UN Convention.

## European Strategy for Older Persons

### **Key points**

The EESC:

- calls for a paradigm shift towards older people, moving away from a care-based approach to focus on empowering them, and eradicating ageist views;
- calls on the EU to adopt a new European Strategy for Older Persons before the end of the current term of office, with the objectives of protecting all their rights and ensuring their full participation in society and the economy.

The strategy should cover the areas of equality and non-discrimination, the gender dimension, rights and access thereto, participation in society, employment, education and training, decent income and social inclusion.

It should also lead to the development of national plans by Member States, including specific targets and indicators.



# European Strategy for Older Persons

#### **Key points**

The strategy should be put into practice by Guarantee for Older People – to serve as a tool to put the new strategy into practice;

The EESC:

- encourages the European Commission and the Member States to urgently draft, develop, sign, implement and monitor a European Declaration on Older People to reflect the commitment to developing a European Strategy for Older Persons;
- requests that the European Commission organises a European Year of Older People, sets up a European Agency for Older People, Ageing and the Demographic Challenge and calls for the adoption of a UN Convention on the Rights of Older Persons.
