## Background



- The SPECA Governing Council approved at its 14th session (Ashgabat, 21 November 2019) the SPECA Innovation Strategy for Sustainable Development and encouraged the SPECA countries, donors and partner organizations to support its implementation.
- The Strategy reflected the ambition of the SPECA countries to develop and consolidate their national capacity to design and implement innovation policies for sustainable development to the mutual advantage of all countries the SPECA region.
- The overall objective of the Strategy is to achieve a sustained improvement in the national capacity and capabilities of the SPECA countries to formulate and implement innovation policies for sustainable development and to raise the level and quality of regional cooperation

## Main objectives of the SPECA Innovation Strategy for Sustainable Development

- <u>Objective 1.</u> Upgrade the knowledge and skills base of key stakeholders in the SPECA countries to meet the challenges of addressing SDGs with innovative solutions
- <u>Objective 2.</u> Facilitate the diffusion of innovations and the transfer of technologies addressing sustainable development challenges in the subregion
- <u>Objective 3.</u> Enhance the institutional framework for subregional cooperation for implementing innovation addressing sustainable development challenges of common interest
- <u>Objective 4.</u> Contribute to improved performance of the SPECA countries as measured against the SDGs

# Key cooperation mechanisms in the SPECA Innovation Strategy for Sustainable Development

- Strengthening the subregional policy dialogue and the sharing of good policies and practices, including the attraction of leading international expertise in innovation for sustainable development
- Working together in identifying subregional and transboundary sustainable development challenges of high priority and common interest that call for innovative solutions
- Raising awareness in the SPECA countries on the role of innovation in achieving the SDGs
- Strengthening cooperation with existing platforms and mechanisms for international cooperation to promote innovation for sustainable development within the United Nations family of organizations

# The Action Plan for implementing the SPECA Innovation Strategy for Sustainable Development

- In a following step, the SPECA Governing Council endorsed at its 16th session (Tashkent, 19 November 2021), an Action Plan of the SPECA Innovation Strategy for Sustainable Development.
- The Action Plan was elaborated through the joint efforts of and inputs from all SPECA countries. This work was coordinated by SPECA Working Group on Innovation and Technology for Sustainable Development
- The Action Plan outlines a set of activities through which the SPECA countries aim to achieve the objectives of the Strategy
- The Action Plan also specifies the governance and monitoring mechanisms necessary for the oversight of progress in implementing the SPECA Innovation Strategy

# Challenges encountered in the implementation of the Strategy and its Action Plan

- The global covid-19 pandemic that lasted for more than two years disrupted implementation
- Travel, trade, tourism as well as face-to-face human interactions worldwide were greatly interrupted
- Being land-locked, the SPECA region was particularly badly affected by these developments
- The disruptions caused by the pandemic imposed the necessity to introduce force majeure changes in implementation
- Some events in the SPECA countries had to be cancelled
- Other events were reformatted into an online format
- Yet other activities were redesigned both in content and format in the spirit of the Strategy objectives
- Overall this resulted in deviations from the envisaged Action Plan

## The evaluation survey



- The Strategy itself envisages regular monitoring of implementation on the basis of periodic evaluation reports
- We are now in the process of preparing the mid-term evaluation report as mandated in the Strategy
- For this purpose the UNECE secretariat undertook a survey among SPECA stakeholders to study their perception of the success/failure in implementation
- A questionnaire was circulated among a large group of leading SPECA innovation experts and practitioners
- So far we received 16 responses to the questionnaire and I take the opportunity to thank all respondents for their valuable effort
- The Survey continues and we expect to receive more responses
- The results of the survey will serve as the basis to compile the mid-term evaluation report as envisaged in the Strategy



- Better understanding of venture financing and access to venture funding
- The SPECA business incubator network a success story

# Most important problems and challenges in implementation of the SPECA Innovation Strategy

- Insufficient resources for the implementation of the Strategy and its Action Plan
- Insufficient geographic coverage of the implementation of actions
- Gap between the Strategy activities and the general awareness of the public in the region regarding its topics
- Gap between the Strategy objectives and the concrete innovation projects in the region, on the one hand, and prospective investors, on the other hand
- Insufficient publicly available information about actual implementation of the Strategy and its Action Plan
- Still low awareness regarding ISD among the public in the region

- More hands-on-trainings which are the most important and useful activities
- Increase the number of face-to-face SPECA events
- Develop concrete new activities targeting the support/facilitation of technology transfer in the region
- Contribute to the development of a SPECA Fund supporting innovation projects and startups
- Contribute to the initiation of concrete cooperative projects among SPECA countries
- Mobilize venture investors and funds to take part in SPECA activities

# Suggested new actions ... (contd.)



- Mobilize more internationally renowned experts to participate in the SPECA events
- Develop SPECA partnership programmes on topics of bilateral or multilateral interest
- Contribute to the development of university-based incubators in the region
- Improve the reporting and dissemination of the implementation outcomes of the Strategy and its Action Plan
- Improve the gender balance in the SPECA activities
- Contribute to the monitoring of SDG achievement in the SPECA region
