

Considering the main outcomes, conclusions and recommendations of the ninth joint session of the Steering Body to the Cooperative Programme for Monitoring and Evaluation of the Long-range Transmission of Air Pollutants in Europe (EMEP) and the Working Group on Effects (Geneva, 11–15 September 2023), the Executive Body will be invited to take note of the progress in the implementation of section I of the workplan (science).

France has expressed its willingness to take over the co-leadership of the Task Force on Integrated Assessment Modelling from the Netherlands as of 2024. Poland has expressed its willingness to take over the co-leadership of the Task Force on Measurements and Modelling from France as of 2024. The Executive Body is invited to reflect the changes in the Task Forces' leadership in their mandates.

5. Mandate of the Coordinating Group on the promotion of actions towards implementation of the Convention in Eastern Europe, the Caucasus and Central Asia

Tentative timing: Tuesday, 12 December, morning

At its forty-second session (Geneva, 12–16 December 2022), the Executive Body requested its Bureau to review the mandate of the Coordinating Group on the promotion of actions towards implementation of the Convention in Eastern Europe, the Caucasus and Central Asia (Coordinating Group), including its scope and composition, and to report to the Executive Body at its forty-third session.² A member of the Executive Body Bureau will inform the Executive Body about the outcome of the Bureau's deliberations on this issue.

6. Policy options to address the conclusions of the review of sufficiency and effectiveness of the Protocol to Abate Acidification, Eutrophication and Ground-level Ozone, as amended in 2012

Tentative timing: Tuesday, 12 December, morning and afternoon

The Executive Body concluded the review of the Protocol to Abate Acidification, Eutrophication and Ground-level Ozone (the Gothenburg Protocol), as amended in 2012, at its forty-second session. The Executive Body decided that an ad hoc group of experts should be convened by the Chair of the Working Group on Strategies and Review to develop policy options to address the conclusions of the review, including consideration of the option of a revision of the Gothenburg Protocol, as amended in 2012, and options for addressing conclusions related to the technical annexes, and including recommendations for next steps and future work.3 At its sixty-first session, the Working Group on Strategies and Review concluded that there was significant support for a revision of the Gothenburg Protocol, including the text and annexes, as the path forward for addressing the conclusions of the review of the Gothenburg Protocol, as amended in 2012, with due consideration to removing barriers to ratification and implementation, in combination with enhancing capacity-building and outreach activities. The Working Group recommended to the Executive Body that it launch a process for revising the Gothenburg Protocol at its forty-third session. The Executive Body is invited to consider the options outlined by the ad hoc group of experts and the recommendations of the Working Group on Strategies and Review made at its sixty-first session, as well as to decide on appropriate action to address the conclusions of the review (ECE/EB.AIR/150, annex I, decision 2022/4).

7. Financial requirements for the implementation of the Convention

Tentative timing: Wednesday, 13 December, morning

The secretariat will inform the Executive Body about the status of Parties' contributions to the trust funds for financing implementation of the Convention in the period 2022–2023 and the expenditures during that period. It will also present resource requirements for the period 2024–2025.

On the recommendation of the Steering Body to the EMEP and the Working Group on Effects, the Executive Body is invited, among other things, to approve: (a) the detailed use of resources for EMEP in 2024; and (b) the essential international coordination costs for financing the core activities of the Convention and its Protocols, other than those covered by the 1984 Geneva Protocol on Long-term Financing of the Cooperative Programme for Monitoring and Evaluation of the Long-range Transmission of Air Pollutants in Europe (EMEP Protocol); and (c) a revised schedule of mandatory contributions for 2024.

The Executive Body is also invited to consider recommendations of the EMEP Steering Body concerning the potential reorganization and relocation of the activities implemented by the Meteorological Synthesizing Centre-East as requested by the Executive Body at its forty-second session.⁴

The Executive Body is further invited, taking into account the resource requirements related to the secretariat's support to intergovernmental activities under the Convention, to consider and approve the proposed budget for the period 2024–2025 and to agree on the corresponding list of priority activities of the secretariat.

The Executive Body is furthermore invited to adopt the proposed budget for promotion and implementation of the Convention in the period 2024–2025 to implement activities listed in sections IV–V of the draft 2024–2025 workplan for the implementation of the Convention (ECE/EB.AIR/2023/1).

9. Review of the rules of procedure for the sessions of the Executive Body

Tentative timing: Thursday, 14 December, morning

At its forty-first session, the Executive Body adopted decision 2021/6 on review of the rules of procedure for the sessions of the Executive Body for the Convention on Long-range Transboundary Air Pollution as adopted by decision 2010/19 and amended by decision 2013/1. With this decision, the Executive Body tasked the ad hoc group of experts, convened by the Chair of the Working Group on Strategies and Review, with undertaking this review and with presenting its final recommendations at the forty-third session of the Executive Body. It requested the ad hoc group of legal experts to undertake a legal assessment of any recommendations for revisions proposed by the ad hoc group of experts.⁵ At its sixty-first session, the Working Group on Strategies and Review recommended that the Executive Body at its forty-third session consider the report on the review in conjunction with the legal assessment and inputs by Parties, with a view to concluding consideration in 2024 and for the Working Group to make recommendations to the Executive Body at its forty-fourth session. The Executive Body is invited to consider the results of the review and the legal assessment and to decide on the way forward.
