OLD LAYOUT TIR CARNET STOCK ANALYSIS

I) BACKGROUND

At its past session, in October 2023, the AC.2 considered IRU's request to extend the transition period for the old layout TIR carnets until 31 December 2024.

The AC.2 approved an extension but for six months only (i.e. until 30 June 2024) and requested IRU to provide detailed information on the number of remaining old layout TIR carnets per country and by when the countries would be able to exhaust this stock, to better understand the reason behind this request.

II) INFORMATION

Since the COVID pandemic, transport and logistics have experienced a number of shocks, which have been also impacting the issuance of TIR carnets. As reported in the past sessions, TIR volumes had been decreasing which results in old stocks not being exhausted as planned.

On 1 January 2024 IRU still had 34% of its stock composed of the old layout TIR carnets while for TIR associations, this share was 54% (Annex I).

In view of the above, the 6 month period will not be sufficient to exhaust both stocks, i.e. of IRU and associations, and the inability to use the carnets in stock would result in significant financial losses related not only to printing, but also to transportation charges, destruction costs, etc.

Moreover, the paper production and printing work performed by IRU's partners are also set up according to a calendar year. Therefore, ending the transition period mid-year may severely impact the supply chain of TIR carnets.

III) REQUEST

Considering the above, the Administrative Committee is requested to:

- Decide that both TIR carnet layouts shall be valid and be accepted by the competent customs authorities until 31 December 2024.
- Have this decision brought to the national competent customs authorities for execution accordingly.
