Literature Collection Activities:

- Collecting relevant information
- Not limited to published articles or academic papers
- May include case studies, videos, conference presentations, papers etc

Steps:

- 1) Collect document, case study, video, etc.
- 2) Identify which category the document best fits into and save it into the relevant folder under Activities
- Open Register document and list high level details- document number is the next available number in the relevant folder
- 4) Open "Summary Template for JT Cases" and "Save As":
 - "[Document number] A Review of [relevant document name]" PLEASE DO NOT SAVE OVER THE TEMPLATE
- 5) Complete your review and save it in the same folder as the document
- 6) If you are part way through the review, please add "Work in progress" to the end of the file name
