CUSTOMS SEED+

TCT/CEFTA Roadmap "Taking forward the Green Lanes"

- Define the legal framework for exchange of data between CEFTA and EU
- Maintaining existing electronic exchange of pre-arrival information (SEED+) from CEFTA to participating EU MS, expansion to all crossings and establishing data matching and sharing findings from EU to CEFTA based on current MoUs, SAAs and DCFTA
- Establishing full (in two directions) electronic exchange of pre-arrival information on all main BCP/CCPs
- Capacity- and trust-building programmes
- Maintaining SEED+ as a monitoring mechanism to provide real time data on waiting times
- Establishing one stops for the main BCP/CCPs and improve/establish adequate infrastructure, IT and equipment to support the synchronised check, as per the BCP/CCPs fiches




STATISTICS: SEED+ WAIT TIME

Calculated SEED waiting for a single frontier crossing includes measured time between:

- Moment when Customs authority at the Customs Office of EXIT (at crossing point) completes customs procedures and allows exit, and
- Moment when Customs authority at the Customs Office of ENTRY (at crossing point) accepts Customs Declaration and allows entry of a truck to the Customs territory:

TIMELINE AT THE BCP/CCP



This means that SEED Waiting Time:

- DOES NOT INCLUDE: waiting at the road/highway, before presenting documentation to the Customs authority at Exit side
- INCLUDES:
 - part of the time at Exit side (after completion of Customs formalities till moment of leaving of Customs territory)
 - o entire time spent for all formalities at Entrance side.

STATISTICS BENCHMARK

- The statistics presents number of trucks, consignements, declarations and waiting time.
- The average waiting time at all BCPs/CCPs in CEFTA in 2022 was 93 minutes.
- Empty trucks have been waiting on average 41 minutes, goods accompanied by the phytosanitary certificate 139 minutes, goods accompanied by the veterinary certificate 136 minutes, while the goods not requiring any certificates have been waiting 100 minutes on average.
- The measurement methodology was developed by the SEED+ project in 2021 and in 2022, all the requirements have been met so that it could be implemented.

This approach may significantly decrease implementation costs and enables faster realization.




WHAT SEED ALREADY CONTAINS?
