## **II. Annotations**

### **1. Adoption of the agenda**

The Group of Experts on cycling infrastructure module (GE.5) is invited to adopt its agenda as contained in this document.

### **2. United Nations Economic Commission for Europe cycling network**

GE.5 was tasked to devise a United Nations Economic Commission for Europe (ECE) cycle route network based on the existing and planned national cycle route networks. At the fifth session, GE.5 discussed a first proposal of a possible partial ECE cycle route network. The incompleteness of the network was due to the fact that no devising of network can be done for countries for which no national or supranational (e.g. EuroVelo) planned or existing network data were shared with GE.5.

At the current session, GE.5 should review the updated version of the proposal for the ECE cycle route network, modified based on the work done by interested countries and the secretariat.

GE.5 should then review and endorse the guide for designation of cycle route networks, as contained in ECE/TRANS/WP.5/GE.3/2023/3/Rev.2.

GE.5 should also review the draft text of its final report pertaining to its work which resulted in devising the partial ECE cycle route network as well as in elaborating, as part of this process, a guide for designation of cycle route networks. It is contained in ECE/TRANS/WP.5/GE.3/2024/2, section 2.

GE.5 would be also expected to consider section 5 (a) of this report which contain draft recommendations pertaining to maintaining and further developing the ECE cycle route network.

### **3. Cycling infrastructure definitions and standards**

The second task for GE.5 was related to elaborating common definitions for various types of cycling infrastructure. In course of its work GE.5 worked out numerous definitions, and at its fifth session, working based on ECE/TRANS/WP.5/GE.5/2023/2/Rev.2 and an in-session document, it agreed on the definitions and the definitions explanatory notes while noting a few minor issues for further consideration.

At the current session, GE.5 is expected to resolve the minor issues and endorse the definitions and their explanatory notes for inclusion in its final report. ECE/TRANS/WP.5/GE.3/2024/2, section 3 contains the draft text of the final report on the definitions and their explanatory notes.

GE.5 should then finalize its work on the definitions of a cycle. At its fifth session, GE.5 considered between options 1 and 2 for formulating the cycle definitions. At the current session GE.5 should agree which of the options should prevail and be included in its final report, in section 4 which contains GE.5 proposals for possible modifications to the 1968 Conventions on Road Traffic and Road Signs and Signals. This part of the report is prepared for submission to the Global Forum for Road Traffic Safety (WP.1) for consideration and decision-making on the GE.5 proposals.

GE.5 should also make a final review of its other modification proposals to the 1968 Conventions on Road Traffic and Road Signs and Signals as they were elaborated in course of its work on the types of cycle infrastructure definitions and were revised at the fifth session. These proposals, along with the cycle definitions proposal, are included in ECE/TRANS/WP.5/GE.3/2024/2, section 4.

Finally, GE.5 is invited to review its recommendations pertaining to its work on cycle infrastructure type definitions, cycle definitions and Conventions' modification proposals. These draft recommendations are contained ECE/TRANS/WP.5/GE.3/2024/2, section 5 (b).
