DETA: The secure internet database for exchanging approval documentation between the Contracting Parties of the 1958 Agreement, as required to be established by the UNECE, according to Revision 3 of this Agreement.

# **DETA - State of play**

#### Facts and figures:

- 37 Contracting Parties have notified their DETA Focal Point
- App. 62.600 approvals uploaded (+17.000) by 19 TAA

- App. 7000 manufacturers (+1100) are uploaded / could be selected by TAA
- 15 manufacturers have access to DETA (only to their own approvals) (manufacturer's access is to be requested via their approval authority and to be forwarded to the DETA Administrator)

# **DETA - State of play – Developments**

#### Mass Upload Functionality

- → implemented in DETA
- TAA are requested to start using the functionality
- Two-factor authentication with e-mail solution
  - → will be implemented with new SW-Version scheduled end of 2024

# **DETA - State of play – Unique Identifier marking**

→ Following the decision by WP.29-191 (ECE/TRANS/WP.29/1175 para. 99), the IWG on DETA prepared a discussion paper for GRE (document DETA-49-03e).

→The IWG on DETA will discuss the results from GRE during its next session.

# DETA - State of play – Extension of scope 1/3

## Extension of scope DETA following WP.29/AC.2 assignment

#### Access for designated Technical Services to all certificates:
