




Release of the "Basics of Quality Infrastructure for Trade," providing base descriptions of all elements of quality infrastructure for trade (November 2023).

Working Party 7 (WP.7) Highlights





Working Party adopted three new and eight revised standards, and one new recommendation, agreed on revised TOR (13-15 November 2023) + roundtable



Seed potato rapporteur's meeting (10-12 October 2023, France)



RFSD: Roundtable on SDG2 (zero hunger), 14 March 2024 (by IBC-SFS) + side-event and regional meeting of food systems national convenors (with UN Food systems Hub + IBC-SFS)



Ongoing: full review of UNECE Standard for Seed Potatoes, drafting a Code of Good Practice for DDP, food loss and waste review of FFV standards, etc.

Supporting United Nations Special Programme for the Economies of Central Asia (SPECA)



Adoption of the SPECA Roadmap for Digitalization of Multimodal Data and Document Exchange along the Tranbs-Caspian Corridor (Baku, Azerbaijan, November 2023):

 The Roadmap envisages action for the digitalization of multimodal data and document exchange from 2027 onwards along supply chains in the Trans-Caspian Corridor, using the semantic standards and Multimodal Transport Reference Data Model of the UN/CEFACT.

Capacity-building seminar to advance to implementation of the Roadmap (Aktau, Kazakhstan, June 2024):

- Clarified the expected efficiency gains from digitalization of cargo information flows along the corridor.
- Addressed the problem of fragmentation of digitalization projects, national and modal legal regimes, as well as different syntaxes
- Explored the results of a pilot testing project, led by TRACECA, on the digitalization of the CIM/SMGS railway consignment note.
- Clarified further steps on integrating the electronic document exchange with the IT systems of national railways in five countries along the corridor: Azerbaijan, Georgia, Kazakhstan, Türkiye, and Ukraine.
